INDIVIDUAL RECEIPT, RELEASE, DISCHARGE AND TRANSACTION

The undersigned **Successful Student Claimant** acknowledges, by the present, having received from **L'Association Selwyn House** (hereinafter "**Selwyn**") the global sum of _____ Dollars (\$) in capital, interest, additional indemnity, costs and all applicable taxes (the "**Payment**") in full, final and global settlement of all recourses, claims, suits, actions, rights, or rights of action whatsoever that he had, has or may have against **Selwyn**, **John Aimers** ("**Aimers**"), **James P. Hill** ("**Hill**"), and the **Estate or heirs of Leigh Seville** ("**Seville**") and their

insurers, predecessors, successors and all their past, present and future directors, officers, representatives, agents, principals, employers, employees and legal assigns directly or indirectly arising from or relating to any (a) Abuse ("Abuse" means abuse of a sexual nature and any physical, mental or psychological abuse directly or indirectly related thereto) alleged or claimed to have been perpetrated by or with the participation of any of the teachers Hill, Seville and/or Aimers, (b) any act or omission of any nature whatsoever by Selwyn in relation to Hill, Seville and/or Aimers and (c) without restricting the generality of the foregoing, the facts and circumstances set out in the Superior Court files bearing numbers 500-06-000310-058, 500-06-000336-061 and 500-06-000335-063, District of Montreal, and the Ontario Proceeding bearing the Ontario Superior Court Number 05-CV-297637-CP or any similar fact or circumstance.

In consideration of the Payment, the **Successful Student Claimant** and his heirs, successors and legal assigns have fully, finally and forever released, relinquished and discharged **Selwyn and Aimers, Hill and the Estate or heirs of Seville**, their insurers, their predecessors and successors and all their past, present and future directors, officers, representatives, agents, principals, employers, employees and legal assigns from and against any and all recourses, claims, suits, actions, demands, rights or rights of action of any nature or kind whatsoever (including any claims for the subrogated interests of any Canadian Public Health Insurer) now existing or which may arise in the future directly or indirectly from: (a) Abuse alleged or claimed to have been perpetrated by or with the participation of any of the teachers Hill, Seville and/or Aimers, (b) any act or omission of any nature whatsoever by Selwyn in relation to Hill, Seville and/or Aimers and (c) without restricting the generality of the foregoing the facts and circumstances set out in the Superior Court files bearing numbers 500-06-000310-058, 500-06-000336-061 and 500-06-000335-063, District of Montreal, and the Ontario Proceeding bearing the Ontario Superior Court Number 05-CV-297637-CP or any similar fact or circumstance.

Further, in consideration of the Payment, without limiting the generality of the foregoing, the **Successful Student Claimant** and his heirs, successors and legal assigns, consent to a bar order that bars the **Successful Student Claimant** from commencing or continuing any suit or proceeding, including but not limited to initiating a proceeding as a class representative or participating as a class member against Selwyn, Aimers, Hill or the Estate or heirs of Seville, their insurers or any other parties who could claim contribution or indemnification from any one of Selwyn, Aimers, Hill or the Estate or heirs of Seville directly or indirectly arising from or relating to (a) any Abuse alleged or claimed to have been perpetrated by or with the participation of any of the teachers Hill, Seville and/or Aimers and (b) any act or omission of any nature whatsoever by Selwyn in relation to Hill, Seville and/or Aimers; and (c) without restricting the generality of the foregoing the facts and circumstances set out in the Superior Court files bearing numbers 500-06-000310-058; 500-06-000336-061 and 500-06-000335-063, District of Montreal, and the Ontario Proceeding bearing the Ontario Superior Court Number 05-CV-297637-CP or any similar fact or circumstance.

In consideration of the Payment, the **Successful Student Claimant** hereby renounces to later demand rescission of the Individual Receipt, Release, Discharge and Transaction for any possible cause including an error of fact or law known or unknown at the present date and recognizes that the Individual Receipt, Release, Discharge and Transaction covers all possible types of claims known or unknown at the present date.

The settlement formalized by the Individual Receipt, Release, Discharge and Transaction intervenes without any admission of liability whatsoever by **Selwyn** and/or **Aimers** or any other person obtaining a release herefrom.

The **Successful Student Claimant** hereby undertakes not to publicize or disclose the Individual Receipt, Release, Discharge and Transaction, its conditions and the conditions of the settlement it is formalizing to any person, corporation, or any other entity not a party to this Individual Receipt, Release, Discharge and Transaction, whether orally or in writing, directly or indirectly and to maintain at all times the strict confidentiality of same. The **Successful Student Claimant** recognizes that the obligations, terms and conditions of the Confidentiality Agreement provided at Schedule G b) are incorporated by reference into the present agreement.

The **Successful Student Claimant** hereby recognizes that the transaction recognized and completed hereby in the actions bearing Superior Court numbers 500-06-000310-058, 500-06-000336-061 and 500-06-000335-063, and the Ontario Proceeding bearing the Ontario Superior Court Number 05-CV-297637-CP constitutes a transaction according to the terms of Articles 2631 and following of the *Civil Code of Quebec*.
